1 Background to Neighbourhood Planning?

- Part of Localism Agenda
- Strong Government commitment
- Simplification of system planning seen as being remote and complex
- Transfer of planning powers
- Focus on planning permissions



Plan Led System

- Decisions should be taken in accordance with the plan, unless material considerations indicate otherwise
- Broadly Hierarchical
 - Planning Acts/New National Policy Framework
 - Regional Spatial Strategy (RSS)
 - Local Plans (at District/Borough level) and
 - Neighbourhood Plans /supplementary planning guidance

They cannot be used to stop growth



- They <u>cannot</u> propose lower levels of growth, housing etc
- But can help inform, direct and shape development
- Should be community led and evidence based
- Subject to independent examination & referendum



2. What is a Neighbourhood Plan?

It is about a community using land and development





Neighbourhood Planning can involve

- <u>Neighbourhood (Development) Plans</u> statutory development plan forms part of the Local Development Framework
- <u>Neighbourhood Development Orders</u> grant planning permission for certain kinds of development within specified area
- <u>Community Right to Build Orders</u> grant planning permission for development schemes

NEIGHBOURHOOD PLAN TOPICS

- settlement boundary
- housing site allocations (inc. types and tenures)
- other land use site allocations
- design guidance and local heritage assets
- green infrastructure protection and improvements
- community facility protection and improvement

3. POTENTIAL BENEFITS OF A NEIGHBOURHOOD PLAN?

Gives communities direct power

- To develop a shared vision for their neighbourhood
- To shape the development and growth of their local area.
- To choose where they want new homes, shops and offices to be built,
- To have a say on what those new buildings should look like
- To have a say on what infrastructure should be provided,
- To grant planning permission for the new buildings they want to see go ahead.



We can also

- Plan for more housing than the Local Authority
- Grant planning permission for development you wish to see
- Protect and enhance the high street
- Choose where new industry and employment should go
- Protect gaps between our towns and villages
- Define and secure local heritage
- Protect valuable green spaces



- Consultation Spring 2016
- Final submission end 2016

- Final approval mid 2017?




7. NEIGHBOURHOOD PLAN AREA COVERED


The area has to be proposed by the Parish/Town Council and approved by the Local Planning Authority(s)

Parish administrative boundary


Options:

- •Link with adjacent parishes













8. How is the Neighbourhood Plan prepared ?







Must engage with the community and other stakeholders:

- residents
- businesses
- interest groups
- public agencies







What is the role of the wider community in neighbourhood planning?

A qualifying body should be inclusive and open ensure that the wider community:

- •is kept fully informed of what is being proposed
- •is able to make their views known throughout the process
- has opportunities to be actively involved in shaping the emerging neighbourhood plan
- •is made aware of how their views have informed the draft neighbourhood plan



Draft Plan is submitted for examination to an independent Inspector who:

Checks that it meets the basic conditions:
Conformity with EU and UK law
Conformity with the NPPF and local policy
Contributes to sustainable development

Recommends:

Whether it's put to referendumWho is included in the vote





Examination result options

- Proceeds to referendum as submitted
- Modified by LPA to meet basic conditions before referendum
- Does not proceed to referendum




Finally, they are subject to a local referendum

•completed plans are referred to a local vote

•plans with more than 50% YES vote are 'made'

•can include voters from a greater area than that of the plan and businesses where appropriate

•50% of those who vote – not those who live or work in the area







Will they make a Difference ?

Eric Pickles has overruled his own planning inspector to block a 111home development in Leicestershire because it conflicts with an adopted neighbourhood plan".



Will they make a Difference ?

- "Developer Larkfleet Homes has applied for judicial review in relation to the Neighbourhood Plan for a Rutland parish".....
- Larkfllet Homes state"We believe that the Uppingham neighbourhood plan is flawed in several areas and therefore not legally valid"
- The Supreme Court disagreed and upheld the Neighbourhood Plan for Uppingham
