EDaN Project

The design of the proposed Northall village sign is almost ready, possible location to be on land at Knolls View.

The Cycleways team require funding for cycle stands to be positioned outside the Surgery in Cow Lane, Janes Shop in the High Street and at the Travellers Rest. County Cllr Avril Davies suggested that application be made to her for money from the Community Leaders Fund.

Traffic Management Team currently discussing the condition of the A4146.

Community Car Scheme is going very well following support from a recent public meeting.

Youth Event is progressing.

A 'Music in Quiet Places' evening will be held at Edlesborough Church in July 2011.

The siting of a planter at Dagnall roundabout is still being pursued with Bucks CC.

It was agreed at the meeting that the cheque drawn to pay for a Licence to plant the tree awarded to EDaN on the corner of Good Intent should now be cancelled.

Dagnall 'Build Out'

A further site meeting had been held with Bucks CC and residents who may be affected by the latest plans regarding the position of an island and alterations at the junction with Studham Lane and excessive shrubbery on the bend in Dunstable Road which would require clearing to give improved visibility.

General Purposes Committee Report

There had not been a GPC meeting in December but the Clerk raised several items regarding matters normally dealt with by the GPC.

It was agreed that the EMH Manager would approach one of the hirers regarding lump sum payments for regular bookings.

The question of possibly raising the half day and one day hire fees will be discussed at the January GPC meeting.

During the recent bad weather the Manager had prepared a Snow Risk report which would be sent to all hirers. All snow clearing equipment has been purchased and is available in the Memorial Hall.

A response had been received from the Land Registry with a new plan showing the correct Ordnance Survey map of the Cemetery and access route which was approved by the Council. It was agreed that the original response would be filed with the Deeds at the Bank.

Cllr Cubbage would approach Mr. Reeve regarding works required to the Memorial Hall car park and once a meeting had taken place the Parish Council agreed to the acceptance of the quotation received for works to the existing car park.

The Clerk would chase the Stonemason for advice and quotation on the refurbishment of the inscriptions and possible polishing of the stonework.

The Villages - (issues other than Traffic Calming and matters delegated to the GPC)

Edlesborough: The mobile library to Edlesborough and Northall had ceased some years ago due to the reduced number of parishioners using the service.

Dagnall: After a period of almost 12 months a letter has been received from Tesco's insurance company admitting that one of Tesco drivers did cause the accident to the streetlight. Quotations and photographs are being sent to the insurance company.

Memorial to Anne Thompson

The Chairman suggested that a clock and plaque be put in the Memorial Hall but asked Councillors to consider other suggestions and the Clerk was authorised to contact other groups for their ideas and whether or not they were considering their own special memorials.
