Minutes of the meeting of the Edlesborough Parish Council held on Thursday 21st January 2010 at Edlesborough Memorial Hall

The Chairman gave a warm welcome to the Parishioners attending the meeting.

Minutes of Previous Meeting

The Minutes were agreed and signed as a correct record

Matters Arising from previous Minutes

There were no matters arising other than under Agenda headings

Declarations of Interest

None declared

Open Forum

The majority of the parishioners present were extremely concerned that The Bell Public House, being the only Public House in the village of Edlesborough, would be closing with a possible sale taking place in September and it being converted into a private residence. The Chairman informed those present that the Parish Council was not able to intervene with individual sales or purchases of this nature and it was suggested that Parishioners could form a Cooperative, as in the case of Ivinghoe Aston, and it was suggested that they may be able to assist a Co-operative. The Parish Council would give its full support if a Co-operative were to be formed. Cllr Wilkinson stated that no planning permission for change of use had been registered but the Parish Council could approach the Planning Authority to see if there has been an application for change of use and would it be necessary, if yes, then the Parish Council

could then express concern about the loss of the last public house in the village and question the Planning Authority as to whether or not the applicants had adequately demonstrated that the pub is no longer commercially viable. Clerk was authorised to contact the Planning Authority. The Chairman informed the meeting that the same problem was occurring at Dagnall with the possible loss of The Red Lion Public House also being the last Public House in Dagnall. EdaN would give support to a Village Community Public House and the parishioners present were urged to make a decision as soon as possible. Mr. Holloway was prepared to get things moving by holding an urgent meeting and to then contact EDaN.

A Parishioner then raised the question of a proposed Kick Wall to be positioned on the Green, and was informed that the GPC were preparing an analysis of responses so far received. Several other issues had arisen from the responses including the anti-social behaviour and vandalism occurring in both the Memorial Hall and Pavilion car parks and the GPC would be taking all these matters into consideration and consult more widely with parishioners before any decisions were made.

Resignations:

Cllr Tim Jones had tendered his resignation which was regrettably accepted by the Parish Council. Notices have gone out for a replacement Councillor for Dagnall Ward.

Cllr Mark Wilson had tendered his resignation from the General Purpose Committee due to work commitments but would wish to remain on the Council. The Chairman was asked to contact Cllr. Wilson. It was confirmed that a Councillor was not expected to exceed non-attendance for 6 consecutive meetings.

EDaN Project

Cllr Williams gave an update on Speedwatch which require more volunteers. Unofficial data to be submitted to Thames Valley Police.

Beautifying the Villages Team have requested permission to hold a May Day event on the Green from 12noon – 4pm. Council were concerned with condition of the Green if wet weather was forecast and confirmation required to be obtained from regular sports users that matches would not be affected. In the past Car Boot Sales had been prevented from using the Green in bad weather to safeguard the surface. The Team also requested permission to go into funds available to install a Village sign on the Green in Edlesborough. The planning permission aspect of the position of the sign would require further investigation. In principle the Parish Council agreed.

Another attempt is being made to 'beautify' Dagnall roundabout.

It was proposed that EDaN and the Parish Council hold a Social Evening sometime in March.

General Purposes Committee Report

Councillors had been handed draft minutes of the meeting held earlier this month. A specification was being prepared to be submitted for quotations to redecorate the main hall of Edlesborough Memorial Hall. GPC recommended paying outstanding Rent Charge for Northall allotments and to arrange a meeting with the owner to discuss possibility of a 'one-off' payment settlement. Parish Council agreed to these measures being taken.

Further discussion to take place at GPC regarding the Kick Wall and to discuss this with the young people of the village. Other issues relating to the Pavilion, car parks. litter picking etc. required more discussion and investigation.

The Villages – (issues other than Traffic Calming and matters delegated to the GPC)

Edlesborough: EB Lions' request to temporarily store floodlights in the Pavilion for approximately 6/7 weeks was

approved by the Parish Council. Council to notify EB Lions lack of use of Pavilion toilets.

Edlesborough: Clerk authorised to send copy of a Parishioner's letter regarding Buses to Bucks CC.

Edlesborough: Following request for improvements to Brook Street parking the Council agreed to extend the existing

parking bay down to the bottom of Brook Street. The question of funding would now be looked into.

Northall: Concerns were expressed regarding the recent water problems in Leighton Road. Clerk had reported

this to Bucks CC who had been and dealt with the initial problem but as water is continuing to flow

along the road it has again been reported.

At the request of the Council Cllr Cubbage agreed to put the accounts under this heading on the website.

Cllr Williams reported that the Firewalk Event had been very successful.

A meeting had been held to discuss the Church Floodlighting which was anticipated to cost more than originally expected due to formal drawings being required, application to Listed Buildings, extra digging for wiring, archaeologist and surveyors reports and anti-vandal cages to house the lights. Further discussions to take place with the Churches Conservation Trust before any further work is carried out. The Parish Council agreed to continue to support this project.

EDaN are seeking funding towards the cost of signs for each of the 3 villages.

The Council approved an expenditure of up to £200 for the supply of high visibility jackets and 2-way radios which each volunteer operating the Speedwatch was required to have.

Disappointingly, EDaN had only received some 50 completed Public Transport Questionnaires out of the 1,000+ circulated with 'Focus' The completed Questionnaires would now be analysed.

EDaN to provide a report on the use of Speedwatch/results before the next Parish Council meeting.

Regrettably nobody had attended the Youth evening held at Edlesborough Memorial Hall.

EDaN will organise an AGM in March/April 2010.
