It was proposed by Cllr Cubbage and seconded by Cllr Brown that a Precept of £67,500, an increase of 8%, be approved. There followed an amended proposal by Cllr Wilkinson which was seconded by Cllr Mrs Ratheram that the Precept be set at £64,000, an increase of 2.4%. The Chairman had the casting vote and the amendment was approved.

#### Traffic Calming;

#### **Speed Limit Review**

No further updates available.

The Council recommended writing to Bucks CC Highways regarding the VAS traffic sign in Northall which currently registers 40mph. When the Speed Limit Review goes ahead and provided the Council's requests are met this would require re-adjusting to read 30mph.

#### Waste Disposal Lorries/HGVs A4146

Clerk reported a news item in the Dunstable Gazette stating that a further £23m had been allocated to the A5/M1 project with a possible commencement date in 2011.

The Parish Council, in conjunction with the EDaN Traffic Management Team, would be forwarding a letter to Bucks CC regarding the degrading of the A4146 to a B road to prevent heavy goods vehicles using the A4146 route.

## Dagnall 'Build Out'

A further bid would be submitted to Bucks CC Delegated Budget for traffic calming measures to be carried out in Dunstable Road, Dagnall together with a request for 3 further Bus Shelters in the Parish.

#### **General Purposes Committee Report**

It was reported that Electrical tests for the Memorial Hall be carried out every 3 years. Under 5's to submit proposals for improvements to the Memorial Hall. Regrettably a child had been injured using the damaged roundabout, the Parish Council have apologised and the roundabout has now been repaired and further work carried out to enable the roundabout to be immobilised if further damage occurs. Further litter bins to be ordered for placing around the parish. Parishioners given the opportunity of responding to the Focus article regarding the installation of a kick wall on the Green. The Parish Council ratified the increased expenditure from £250 to £300 for clearing the five redundant Cow Lane allotments. It was agreed by the GPC to increase the Cemetery fees as from 1st February 2010.

At a recent meeting with Thames Valley Police it was recommended to install an alarmed padlock on the bridleway gate. Following discussion at the full Parish Council meeting and taking into account that the current padlock is now covered by a metal box and no further problems have occurred it was agreed to leave things as they were at present, but if problems re-occurred the Council would fit an alarmed padlock. The Clerk was authorised to write to Thames Valley Police explaining the Council's decision. A decision to replace the existing bridleway gate/barrier has temporarily been put on hold. Quotations to be sought for re-engraving the names on the War Memorial.

# The Villages – (issues other than Traffic Calming and matters delegated to the GPC)

Edlesborough: Bucks CC have no objection to extending the existing parking bay and installing bollards in Brook

Street. Clerk to write to all residents, shops and cottages in High Street to seek their views.

Edlesborough: The road closure and diversion signs erected for the Remembrance Service had proved very

successful and the public were able to stand in the road. Signs depicting when the roads will be

closed will be erected at least 10/14 days before the next service which is to be held in 2011. The

Parish Council appreciated the assistance of Lorna Cubbage for organising the signs and William

Pratt for having kindly put out and taken back the signs on the day. Letters of thanks to be sent to

both.

Northall:: Cllr Cubbage requested that the Parish Council Notice Boards and Parish Paths Partnership sign

Boards be cleaned and refurbished, not only in Northall but to include Edlesborough and Dagnall.

#### **Local Transport Plan (LTP3)**

Cllrs Wilkinson and Williams to discuss a formal response which the Parish Council would discuss at the December meeting for a decision to be made on the Council's submission.

#### Items to Report to Police

The main door to the Memorial Hall and the Memorial Hall Notice Board have been vandalised.
