General Purposes Committee Report

Councillors had received copy Minutes of the meeting held in September. The main discussion had been on the cleaning and rising costs of The Pavilion and hire charges for the Memorial Hall. Further advertisements for hiring the Memorial Hall have been placed around the villages. Improvements carried out to the Memorial Hall as requested by Under 5's. Repairs to be carried out to the Play area equipment by Wicksteed Leisure. GPC currently considering quotations for a new Bridleway Gate. Road/pavement repair works reported to Bucks CC and AVDC. Wasp nests are to be professionally removed from the relevant Churchyard/Cemetery areas.

The Villages – (issues other than Traffic Calming and matters delegated to the GPC)

Edledsborough: New Moor End and High Street signs being erected in Edlesborough

Edlesborough: A previously donated Litter Bin for The Green has been vandalised and removed for safety reasons.

The Clerk was authorised to write to the Parishioner pointing out that permission should have been

obtained from the Parish Council before donating the bin

A public consultation was held prior to the Council installing the Basketball Goal on The Green and

parishioners will be asked their views prior to erecting a kick wall

Clerk was authorised to contact Bucks CC to discuss increasing the hard standing in Brook Street using Grasscrete, as laid in the Cemetery turning circle, and it's views on installing bollards near the junction with the High Street.

The Certificate for runner up in the Best Kept Village Competition will be hung in the Memorial Hall.

Response from Bucks CC that the Council's request for Dropped Kerbs at Church Croft will be

reviewed by the Traffic Management Team

Proposed by the Chairman and seconded by Cllr Cubbage for the hedge around the Pastures to be

tidied up and brambles removed

Dagnall: A successful meeting had recently taken place with Bucks CC regarding the Build Out and further

traffic calming. Bucks CC would come back to the Council with a proposed scheme so that the

Council could submit a Bid for the Bucks CC Delegated Budget.

General Purpose Committee to deal with requests for more litter bins throughout the Parish.

P.A.I.N Report (Cllr Wilson declared an interest)

The Parish Council are in possession of a copy of the Luton Airport AMR for 2008 published by Luton Borough Council and London Luton Airport Operations Ltd. The annual report gives detailed statistics relating to aircraft movements, passengers carried, runway usage, noise level monitoring, complaints, employment and surface access.

Notable changes since the 2007 Report are:

In 2008 the Airport handled 10.2 million passengers compared with 9.9 million in 2007 an increase of 2.5%

The number of commercial passenger aircraft movements increased by almost 3% but the total number of aircraft movements deceased by 2% primarily as a result of fewer cargo and general aviation movements.

The proportion of scheduled flights compared with charter flights continues to increase. Easyjet remain the biggest operator, Ryanair next biggest followed by Wizz Air.

There was a decrease of 4% in night movements.

The number of complaints were reduced but with slightly more complaints from the Parish in 2008, 5 from Dagnall and 2 from Edlesborough compared to 1 from Dagnall in 2007.

The split of Westerly to Easterly operations in 2008 was 70% to 30%, similar to previous years. During Westerly operations approximately 20% of departing aircraft use a flight path that nominally overflies the Parish (Dagnall, Edlesborough and Northall). During Easterly operations, 100% of arriving aircraft overfly Dagnall.

Details of the NTS TCN consultation should be available shortly to which the Parish Council will be responding.
