#### **Planning Issues**

### Development at rear of The Swan, Leighton Road, Northall

Some improvements have been made to the Lane and the splayed access and pavement are due to be carried out when the first property is occupied.

#### **Pitstone Quarry**

The decision on an amended application for 'restoring' Pitstone Quarry 2, due for hearing on 21st April, has been postponed.

### County & District Councillors' Reports

<u>County Clir Avril Davies</u> enlarged upon the Pitstone Quarry application and reported on her up to date communications with the Cabinet Minister for Buckinghamshire County Council regarding the recent increase in HGVs using the B488 and A4146 to reach the Stoke Hammond bypass. A Freight Quality Partnership for Buckinghamshire would be set up which would involve County, District and Parish Councils, local people, the freight transport industry, Police and other interested parties such as map and satellite companies in advising drivers and their employers of suitable routes for HGVs to mutual benefit. Reference was made to the Luton Core Strategy, a copy of which the Parish Council had received to which it would be submitting it's comments in due course.

<u>District Cllr Terry Jones</u> gave information regarding the Core Strategy and Direction of Housing Growth at Aylesbury. The new Theatre in Aylesbury is well under construction. AVDC have access for funding for anyone starting a small business where people can rent business premises on a monthly basis.

## Speedwatch

The Council are in the process of purchasing Speedwatch equipment with volunteers being trained to man the equipment prior to it being used extensively throughout the Parish.

The Chairman of EDaN, Cllr Williams, gave a presentation of a proposed 'Fire Walk' to take place on Edlesborough Green on Saturday 7<sup>th</sup> November. This was approved by the Parish Council who also approved of the £200 deposit required.

An initial flood lighting test had been carried out at Edlesborough Church and further details would be available at the next meeting.

EDaN's request for sponsorship for planters was discussed and Invoices would be sent out on Parish Council's letterhead with a covering letter drafted on EDaN notepaper.

#### **Traffic Calming:**

### Speed Limit Review

Confirmation had been received from Bucks CC that work on the Speed Limit Review for Area 13 has now commenced and an area briefing meeting would take place on 19<sup>th</sup> May to present local councillors with up to date information followed by a public consultation to take place this summer and for new limits to be in place by Autumn 2009.

#### A4146 Waste Disposal Lorries

A representative from the Parish Council had attended a recent meeting at Great Gaddesden who are also affected by the Waste Disposal Lorries at Water End. It was unanimously agreed that the Council would write to John Bercow MP seeking his help in getting Bucks CC involved with the issues raised at the meeting.

#### **General Purposes Committee Report**

The Chairman of the GPC gave details of the matters discussed at it's April meeting. All users of the Memorial Hall and Pavilion had been asked to sign an annual Hire Agreement. The Under 5's wish to have additional conditions included in the Standard Conditions of Hire and it has been suggested that a meeting take place to discuss their proposals.

The boilers at the Memorial Hall have been serviced, further allotments let and approval given for Cemetery memorials.

#### **Cemetery Access**

Initial works to improve the access from the bridleway into the Churchyard have been completed and the remainder of the access route should be completed within the next two to three weeks. The Parish Council approved the acceptance of a quotation for a new gate to be installed.

#### The Villages - (issues other than Traffic Calming and matters delegated to the GPC)

The Parish Council will be entering Edlesborough in the 'Best Kept Village' Competition, Dagnall and Northall do not qualify under the existing rules.

Edlesborough: A request was made for Dog Bins to be erected in Cow Lane and Summerleys and it was stated that

a dog bin was already sited in Cow Lane and permission would have to be sought from the owner

of the field at the bottom of Summerleys to erect one on private land. This item would be placed on

the Agenda for the May meeting.

Edlesborough: The concerns raised by a Parishioner at the Annual Parish Meeting regarding Brook Street verges

and the vandalised Telephone Kiosk would be discussed further at the next PC meeting.

Dagnall: A request for the white zig-zag lines to be repainted outside Dagnall School has been made to Bucks

CC. Northall: The continuing problems with excessive water at the junction of Eaton Bray Road and the A4146 are

to be again reported to Bucks CC.

## Freedom of Information Act

More work needs to be done.

### Core Strategy and Direction of Housing Growth at Aylesbury

This was discussed at length and proposed by Cllr Wilkinson that Edlesborough should not be classified as Tier 4 as it does not fit into the criteria. A vote was taken amongst the Edlesborough Councillors with the result being 4 to 1 in favour of the proposal.
