Traffic Calming Reports

Waste Disposal Lorries

No response received to date from Bucks CC regarding the Waste Disposal Iorries and increase in traffic since the opening of the Soulbury By-Pass. Registration numbers of Iorries have been sent to Bucks. CC. This matter will be on the Agenda at the GC2C meeting on 27th March.

Streetlighting

Edlesborough: Due to an accident the Cow Lane streetlight had to be demolished, arrangements are in hand to

have the this streetlight replaced. Clerk to check insurance policy.

Due to unforeseen cicumstances the Parish Council apologises to Parishioners for the continued

delay in getting streetlights repaired.

Dagnall Work still waiting to be carried out across the allotments.

Northall Letter received from Bucks CC who will look into ways of reducing traffic on A4146 as opposed

to the large expenditure necessary to create an extension to the footpath.

The Chairman informed the meeting that Safer Routes to School have received confirmation of substantial grants for improvements to the Bridleway from Ivinghoe Aston to Edlesborough. The Clerk is contacting the landowner of the Edlesborough part of the Bridleway for permission for the work to go ahead.

Community Speedwatch - Cllr Williams to give an update report at the next meeting.

The Villages - issues other than Traffic Calming and matters delegated to the GPC

It had been agreed to include a list of 'Who To Report To' on the website.

The Chairman and Clerk had recently attended a Community Action Rural Housing launch which proved very informative. Rural Housing is for young people wishing to have the opportunity of having a home of their own in their local village for which suitable development sites are required.

Dagnall: The flashing lights have now been repaired and rubber strips laid across the road.

Dagnall: The Chairman had attended a recent Transport meeting and reported that the 176 bus to Milton Keynes had been withdrawn due to loosing £100 each run on top of subsidy. The buses from Dagnall to Dunstable and Hemel Hempstead are being retained. Also retained is the Leighton Buzzard bus service running daily but with very restricted timing which will be addressed by the Parish Council. The Parish Council's request to arrange for the 61 bus to pick up in Dagnall is still on the Agenda.

The Chairman reported the death of Cllr Ron Treacher, Chairman of Pitstone Parish Council. The Chairman, Cllr Wilkinson and the Clerk had attended his funeral and were amazed at what a full, varied and active life he had led, a truly remarkable man.

Separate quotations to be sought for play equipment and safety surfacing for Northall play area and for Dagnall play equipment up to date of renewal.
