#### Matters Arising from the previous Minutes

#### Aylesbury Vale Local Committee

The Clerk advised that over the past 2 years requests had been made to Bucks. CC regarding the Parish Council's priorities for footpaths

- 1. To extend the footpath from Chapel Lane to the Slapton Turn in Northall. This path is listed on the 2006/7 delegated budget, having been carried over from the 2005/6 budget, but it does not rate sufficient priority compared with the competing bids to stand any chance of being successful this year. Furthermore, if the AVLC put an upper limit on the value of individual bids as anticipated, this bid will probably no longer qualify for inclusion on the list.
- 2. To provide a footpath from Dagnall to the main B489 and Church End to Pine Road. These two paths were turned down in January/February 2005 by the Promotion and Development Group. The Parish Council will re-submit them as delegated budget bids for inclusion in the budget.
