### **Matters Arising from the previous Minutes**

The Chairman referred to the Community Support Officer funding and although the Parish Council were of the opinion that Edlesborough Parish would share the cost with Pitstone, Pitstone had not been made aware of this. Pitstone Parish Council will be discussing this project and come back to Edlesborough with their decision. Clerk requested to write to Thames Valley Police to ascertain a start date, cost to the Parish Council and who the Parish would be sharing the officer with.

It was clarified that previous reference to AVDC Local Committee should be Aylesbury Vale Local Committee and future minutes would refer to the correct title.

### **General Purposes Committee Report (GPC) incl. Churchyard**

It was reported that considerable discussion had taken place at the last General Purposes Committee meeting regarding continuing vandalism which is becoming a big problem in Edlesborough. The Euro bin had been set alight, an external light on the Memorial Hall smashed, turf uplifted on The Green, cricket nets strewn over The Green and more graffiti appearing. The Memorial Hall has received a new Premises Licence and allotments recently 'given up' are being re-let.

### **Traffic Calming Reports**

*Dagnall:* Letter sent to Bucks. CC regarding the 'Build Out'.

*Edlesborough:* Parish Council to go ahead with the addition of roundels and yellow backed signs.

Following information received regarding the addition of double yellow lines to be painted in Summerleys with the junction of High Street, the Clerk would write requesting that similar action be taken at the top of the High Street between the bus stop and junction with the A4146 and from Church Croft to St. Mary's Glebe. The Parish Council considered the parking in Summerleys was more of an issue than double yellow lines at the junction and this would be put to Bucks. CC.

*Northall:* Nothing to report.

### **Tennis Club Lease**

A draft Lease had been received which was not considered appropriately written for the Tennis Courts, a revised draft Lease has been requested prior to the next full Parish Council meeting in January.

### **Community Bus**

A bid for 2 buses to serve the east side of Aylesbury vale (Stoke Hammond to Dagnall) on a demand responsive basis has not been successful. Rural transport grant funding had been spent entirely on increased subsidies to existing services. The bid for a community bus will be pursued.
